NOTICE TO ALL CLIENTS

Re: Notification of a pending AQIS rates increase July 2009

We have been recently advised by AQIS that due to a change in Government policy all AQIS fees are to increase across both the import and export sectors. In some areas we face increases of over 40%.

We understand these are tough economic times, but the absorption of these increases would have a direct impact on the economic viability of our business and thus we have no other alternative but to pass on these increased costs.

All AQIS rates will be adjusted on the 27th July accordingly.
